## RENOUNCEABLE NON-UNDERWRITTEN RIGHTS ISSUE OF DISCOUNTED AND REDEEMABLE CONVERTIBLE BONDS

### - CONVERSION AND CANCELLATION OF CONVERTIBLE BONDS

## 1 INTRODUCTION

- 1.1 The Board of Directors (the “**Board**” or “**Directors**”) of Addvalue Technologies Ltd (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to the Company’s previous announcements made on 7 July 2022, 14 July 2022, 5 September 2022, 26 September 2022, 30 September 2022, 11 October 2022, 2 November 2022 and 4 November 2022 (the “**Previous Announcements**”) in relation to the Rights Issue. The Convertible Bonds were issued on 4 November 2022 and listed and quoted on the Mainboard of the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) with effect from 9.00 a.m. on 8 November 2022.
- 1.2 Unless otherwise defined in this announcement, all capitalised terms used in this announcement shall have the same meanings and construction as ascribed to them in the offer information statement dated 11 October 2022 issued by the Company in relation to the Rights Issue (the “**Offer Information Statement**”).

## 2 CONVERSION AND CANCELLATION OF CONVERTIBLE BONDS

- 2.1 Further to the Previous Announcements, the Board wishes to announce that the Company had, on 5 January 2026, allotted and issued 44,379,812 Conversion Shares to Bondholders at the Conversion Price, following conversion of the Convertible Bonds with an aggregate principal amount of S\$754,457, in accordance with the Terms and Conditions.
- 2.2 Following the allotment and issuance of the Conversion Shares: (a) the outstanding aggregate principal amount of the Convertible Bonds has decreased from S\$3,456,608 to S\$2,702,151; and (b) the issued and paid-up share capital of the Company has increased from 3,490,192,675 Shares to 3,534,572,487 Shares (excluding treasury shares). The Conversion Shares will be listed and quoted on the Mainboard of the SGX-ST on or about 15 January 2026 from 9 a.m. onwards.
